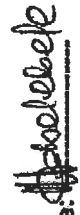

PART B: OUR STRATEGIC FOCUS

Updated Situational Analysis

External Environment

South Africa is at a crossroads and, as witnessed in patterns of socio-political instability, the democratic dispensation faces major challenges. Contrary to initial estimates, the pandemic has *not* been the *great equaliser*, *it was particularly vicious on the livelihoods and wellbeing of those who were already on the margins of society*, those in the periphery of our cities, small towns, townships and rural villages, where the poor and marginalised are concentrated. Despite the substantial and visible progress we have made in all spheres of development, we remain one of the most dangerously unequal societies in the world, with more than half of our population living below the poverty line. We are the first to acknowledge that, despite our best intentions, the systemic legacy of over 300 years of colonial conquest and exploitation, the unabated plundering the wealth producing resources of our land and the resultant underdevelopment cannot be corrected and redressed in just under three decades of the democratic dispensation.

What persists to be of particular concern to all of us is the extent to which our society remains characterised by an unhealthy concentration of income, wealth, power and opportunities in the hands of those already well placed and a steady rise in chronic levels of social and economic insecurity for those in the margins of society. The picture worsens when we turn our attention to wealth inequality, assets inequality and the disproportionate debt burden along racial lines

The South African government recognises the need to address these disparities and has therefore developed policies and frameworks aimed at promoting a just, equitable and humane developmental state. Over the MTEF period, the department will continue to confront gender-based violence and support the socio-economic empowerment and emancipation of Women, Youth and Persons with Disabilities. We will continue to promote responsive planning, budgeting, monitoring and evaluation across government; supporting youth empowerment; promote and advance the rights of people with disabilities.

Youth Unemployment as National Crisis

As households and communities come to terms with the extent of the social, economic and livelihood devastation that the Covid-19 pandemic left behind, South Africa's post-1994 democratic dispensation is at crossroads. Contrary to initial estimates, the pandemic has *not* been the *great equalizer*. Although we were faced with the same virus, its impact has particularly paralysed the livelihoods and wellbeing of those who were already on the margins of society, those in the periphery of our cities, small towns, townships and rural villages, where the poor and marginalised are concentrated.

The more than half (50%) of our population that lived in poverty before the pandemic was pushed further down the livelihood ladder, and many more have joined the unemployed, particularly the youth. The limited asset base they had built was further weakened, leading to the rise of precarity and general socio-economic insecurity. As far back as the first quarter of the year 2020, South Africa already experienced record levels of unemployment, particularly amongst youth.

Against this backdrop, to make the most of available resources beyond our department, we will be rallying all of government and all of society to treat and respond to unemployment in general and youth unemployment in particular as a national crisis and an apex priority of the South African government. To this end, the Department is leading a process of developing a sector-wide Youth Employment Action Plan for implementation by government, state owned entities, national public entities, private sector, parastatals, and development partners.

Furthermore, the Department is also coordinating implementation of the 4IR (4th Industrial Revolution) Youth Digital Skills and Employment initiatives, aimed at assisting the youth to acquire the much needed 21st century digital skills for employment and entrepreneurship. The delivery of this programme will be in line with the District Development strategy where Information and Communication Technology skills will be aligned with the demands of a specific district will be offered. The District Incubation Centres will become the hub that defines the Digital Skills need of that particular district. Two Digital Skills domains will drive the digitization of each district and these domains will be Digital Skills for All domain as well as the Skills for Employability domain. Digital Skills for all, will focus on provision of digital skills to young citizens, and this will include

courses such as Digital Literacy, Information Technology Essentials, Networking and End-User computing. Digital Skills for employability will equip the youth with skills such as Digital Marketing Training; Cybersecurity; Software Development and Networking, etc.

Livelihood Restoration, Wealth Creation, Poverty and Hunger Alleviation Programmes in 5 of the top 10 Poorest District Municipalities in South Africa:

- **Integrated- Farming Value Chain Cooperatives**

Poverty-stricken communities face numerous challenges, including hunger, weakened livelihoods, limited economic opportunities, little to no income and inadequate access to resources. These challenges contribute to a cycle of poverty, which disproportionately affects women and youth, particularly those in rural and township communities. Against this backdrop, we have adopted an **All-of-Government and All-of-Society Approach to Livelihood Restoration, Wealth Creation, Poverty and Hunger Alleviation** through special projects that will be rolled across 5 of the country's top 10 poorest districts, where the greatest need exists.

Against this backdrop, the Department, in partnership with our Universities, TVET colleges and existing NPOs with capacity to train and empower participating communities, will be rolling out **Integrated Farming Cooperatives** in South Africa's poorest districts during and beyond the 2023/24 Financial Year, with a particular focus on youth, women and PWD for poverty alleviation, livelihood restoration, food security and wealth creation. The primary objective of these projects are to reduce the impact of extreme poverty, hunger, unemployment, and basic socio-economic insecurity, restore livelihoods and build community wealth through Integrated Crop-Livestock Farming Cooperatives.

Agricultural cooperatives to be rolled out in these districts will seek to maximise mutual support and economies of scale by enabling farming individuals, families or communities to pool resources together, share equipment, and jointly purchase inputs to create economies of scale lower costs, increase bargaining power with suppliers and buyers, and improve their productivity and competitiveness.

We will focus on the following 6 poorest district municipalities: OR Tambo; Amatole; Harry Gwala; uMzinyathi; Vhembe; and Sekhukhune

Community Micro-Bakeries and Confectionery Projects

Linked to the integrated farming cooperatives, the department will partner with public, private and non-profit entities to train and capacitate over 300 Women, Youth and Persons with disabilities in at least three of the poorest municipalities to establish, run and sustain Community Micro-

Bakeries and Confectionery projects. In addition to creating much needed jobs, this initiative will support local economies and empower communities to be resilient, self-sustaining and self-reliant.

All-of-Government and All-of-Society Approach to the Implementation of an SANDF-led National Service.

The youth of this country represent a blessing with limitless potential and possibilities. However, the current state of poverty, idleness and general economic inactivity amongst our population in general and the youth in particular present a direct threat to national security. According to Section 198 (a) of our constitution, which deals with principles that anchor the character of our security services, a state of National security must “reflect the resolve of South Africans, as individuals and as a nation, to live as equals, to live in peace and harmony, to be free from fear and want and to seek a better life”. As things stand, we do not live as equals. As things stand, communities live in fear due to violent crimes and GBV, we do not live in peace and harmony, and neither are we free from fear. As things stand, our people are not free from want, more than half of them live in poverty. In sum, the current state of our nation directly contradicts, and is inconsistent with Section 198(a) of our constitution.

Against this backdrop, in this financial year, under the guidance of the Commander-in-Chief, our department will rally all-of-government and all-of-society behind the finalisation and implementation of an SANDF-led National Service, primarily targeted at the Youth, Women and Persons with disabilities, and geared to accelerate our nation's post-pandemic recovery, reconstruction and the attainment of our national development goals.

An SANDF-led National Service we have in mind will seek to:

- Train and capacitate our communities to be resilient and self-sustaining, massify sector-specific skills development, power up our nation's industrialisation aspirations and grow local economies.
- It will kick-start a deliberate skills revolution open to every South African son and daughter, preparing them to meet the country's current and future professional needs, and for a future free of want and basic insecurity.

- Armed with military capital, the National Service will give our communities an invaluable identity that embodies discipline, patriotism and professionalism of the highest order. It will mobilise and organise our communities into force multipliers and first respondents to some of the nation's most immediate challenges, such as crime, poor infrastructure, low levels of literacy, inadequate access to primary healthcare, etc.
- Overall, we are putting forward an SANDF-led National Service as the mainstay of efforts aimed at ensuring the existential continuum and attainment of a secure state by adding value to our population, our territorial integrity, the functioning of our government (particularly its ability to deliver services), and the ability of our nation enter into relationships that advance our national interests and national wellbeing.

Cooperative Bank

The Department of Women, Youth and Persons with Disabilities (DWYPD), as an advocate and custodian of economic inclusion of WYPD, will be collaborating with the Co-operative Banks Development Agency (CBDA) and other key stakeholders to develop a concept document to support more women, youth and persons with disabilities to establish Cooperative Banking Institutions (CBI). Empowering cooperatives through this niche approach will improve the sustainability and viability of cooperative-based businesses. Cooperative banks have always been an important part of many successful financial systems. We are confident that through our partnership with the Co-operative Banks Development Agency (CBDA) and other stakeholders will go a long way towards improving financial and economic inclusion of the marginalised communities.

Benchmarking on BRICS Poverty Alleviation Programmes

Women, Youth and Persons with Disabilities (WYPD) constitute the largest section of the population in South Africa, and they experience the highest levels of poverty and inequality. A number of poverty reduction interventions have been put in place, with varying degrees of success. In the main WYPD continue to experience growing levels of poverty and inequality, which has further been exacerbated by the COVID-19 pandemic. Although Government's response to decrease the negative impacts of the COVID-19 pandemic is the Economic Recovery and Reconstruction Programme (ERRP), the programme has thus not been responsive to the needs, interests and concerns of WYPD. Youth unemployment is the highest it has ever been, and the face of poverty continues to be that of a black woman.

It is therefore essential to determine what poverty reduction programmes are working well in other countries and where poverty levels experienced by women, youth and persons with disabilities have decreased. In this regard, the Department as a member of BRICS will be benchmarking against these successful poverty alleviation programmes. It is imperative to identify what these best practices are so that we can learn from the lessons and replicate such best practices in South Africa. The intention must be towards meeting the Sustainable Development Goals by 2030, in particular the SDG seeking to alleviate poverty in the future and ensure food security for all.

Gender Based-Violence and Femicide (GBVF)

The continued GBVF crisis warrants the positioning of GBVF at the level of a second pandemic. Section J of the Resolutions of the second Presidential Summit on GBVF held on 1 – 2 November 2022 recognises nine (9) key challenges and gaps that persist.

These further provide a rationale for a targeted, tangible and deliberate approach to tackling GBVF viz:

1. Failure to establish the legislative and institutional framework within the allocated time frame as set out in the NSP on GBVF for leading and coordinating the response;
2. Failure to adequately promote and institutionalise the NSP on GBVF;
3. Arbitrary deviations from the commitments made in the NSP on GBVF when implemented;
4. Lack of coordination that results in a fragmented response, duplication of efforts, wastage of resources, and impact evaluation;
5. The continued disconnect to see GBVF as discrimination;
6. The trust deficit that continues to exist amongst the key actors as a result of the ongoing failure of the State to meet its constitutional obligations;
7. Rampant impunity, lack of accountability, and consequence management;
8. Lack of gender-responsive budgeting, thus leading to an inadequate national response to GBVF and

9. An inadequate whole-of-society response to decisively deal with patriarchal, misogynistic, and heteronormative culture systems and practices in families, communities, and social institutions.

COVID-19, as the singularly defining period of the last three years, deepened and widened the collective trauma of all living in South Africa. On 18 June 2020, the President noted that about 21 women and children had been killed in the two weeks preceding the address. In this address, the President recognised GBVF as a second pandemic in the country, on par with COVID-19. Teenage pregnancy, a social ill closely linked to GBVF, also spiked amid the COVID-19 pandemic. GBVF is culturally rooted and patriarchal attitudes are entrenched in societal norms, cultural practices such as forced marriage through Ukuthwala and attitudes. Some practices such as ritual killings contribute to the GBVF scourge. GBVF is further fuelled by gender-based inequalities in the economic, social and political spheres. These inequalities are entrenched in structural and systemic poverty and structural unemployment that mostly affect women. All this is evident in: (i) the extent and brutality of rape and murder experienced by women, children and LGBTQIA+ persons; (ii) how women experience a lack of safety and respect for their human dignity and autonomy in their private and public lives; (iii) how women experience a lack of agency and power in the economic, social and political arenas; and (iv) the degree to which there is impunity and insufficient individual, state and societal accountability with regard to GBVF. Of grave concern is the intergenerational cycle of violence. If young children experience childhood violence, then as they become adults, boys are more likely to perpetrate violence (and GBVF) and girls are more likely to become victim of it. This situation brings to the fore the importance of social behaviour change programmes targeting boys for example, gender transformative initiation school's curriculum. The importance of tackling GBVF in the fight against HIV and AIDS is also important, for example, 'forced sex may directly increase the risk of HIV transmission as a result of physical trauma; violence or threats of violence may limit the ability to negotiate safer sex; inadequacies in justice systems may result in a disincentive to reporting rape and/or seeking post-exposure prophylaxis; childhood sexual abuse may lead to sexual risk taking in later life; and sharing HIV results may increase the risk of a violent response by a partner. The UNICEF 2020 World AIDS Day Report indicated that globally, new HIV infections were 3 times higher among female adolescents relative to their male counterparts. In South Africa, vulnerability also remains heavily skewed against girls and young women. Data challenges ranging from unavailability and underreporting undermine our understanding of the full scope of GBVF. This illuminates the importance of a prevalence survey and research to inform a more effective response to GBVF.

The continued chronic GBVF crisis over many years warrants the positioning of GBVF at the level of a second pandemic. The President in calling the second Presidential Summit demonstrated proactive political leadership and commitment. The COVID-19 pandemic proved that where all hands are on deck, and there are deliberate efforts to invest, it is possible to have impact. Moving the needle in the fight against GBVF requires a similar approach. In the context of GBVF:

- An intentionally more hopeful narrative needs to be shaped in relation to GBVF;
- Bold leadership matters and needs to be amplified;
- Appropriate mechanisms and institutional arrangements to give effect to cooperative governance must be put in place;
- Shaping a discourse that asserts state accountability and collective societal responsibility is a priority; and
- Strengthened efforts have to be made to build co-ownership by different sectors.

To close loopholes, and to complement and augment the current initiatives, GBVF should be treated as a second pandemic as pronounced by the President. This will provide additional impetus in the fight against the scourge through harnessing, centering and elevating accountability, coordination and leadership of society as a whole.

National Youth Development

Youth unemployment persistently remains high, irrespective of young people's education levels. Government has interventions in place to stimulate job creation in various sectors such as agriculture, public works, creative industries, community service etc. However, the continued increase in youth unemployment figures suggests that these interventions are making very little impact.

According to the National Development Plan, the unemployment rate should fall from 24.9% in 2012 to 6% by 2030. This will require an additional 11-million jobs. Total employment should rise from 13-million to 24-million; public employment programmes should reach 2-million people. The department is conducting a study to evaluate government youth employment programmes, to be concluded at the end of 2023/2024, which is critical in providing evidence on how the current and future programmes can be strengthened to replicate those that have high impact; scale them

up to reach many young beneficiaries; increase their sustainability; and assess value for money in relation to achievement of the set priorities. The evaluation would focus on selected government youth employment creation programmes and assess the progress made towards the achievement of results, over five-year financial year (2015/2016 to 2020/2021). The extent to which the programmes increase the likelihood of youth being employed will be determined.

2023 BRICS Youth Summit and Ministers for Youth Meeting

The National Youth Development Agency (NYDA) and the DWYP, will host the 2023 BRICS Youth Summit and Ministers as well as Heads of Executive Authorities responsible for Youth Meeting in July 2023. South Africa's priority would be to present and ensure adoption for establishment of the BRICS Youth Secretariat, intended to follow up for implementation of decisions taken at the BRICS Youth Summit.

Climate Change Adaptation and Vulnerabilities of Persons with Disabilities

Persons with disabilities in low-and-middle income countries (LMIC) experience socio-economic vulnerability to the effects of climate change, beyond the physical vulnerability experienced by their broader communities. Previous literature has begun to identify the differential impacts of climate change for persons with disabilities which requires further examination. For example, climate change threatens persons with disabilities' living standards and health such that, "climate change scenarios will result in a range of worsening health impacts, including greater risk of injury, disease, and death due to more intense heat waves and fires; floods; increased risk of under-nutrition from diminished food production; and increased risk of food-, water-, and vector-borne diseases". Therefore, the Department of Women, Youth and Persons with Disabilities, through the Rights of Persons with Disabilities Branch, proposes to collaborate with partners and other stakeholders who are involved in furthering the climate action research and advocacy agendas for persons with disabilities. The Department will further develop a status report on the impact of climate and the promotion of inclusion of persons with disabilities in climate change action, adaptation and mitigation strategies.

Strengthen Access to Justice for Persons with Disabilities

To be fully included in society, persons with disabilities need access to justice. As long as they face barriers to their participation in the justice system, they will be unable to assume their full responsibilities as members of society or experience their rights and to enjoy the equal opportunity to perform their duties as witnesses, jurors, lawyers, judges, arbitrators, and other participants in the administration of justice.

It is against this background that the Department of Women, Youth and Persons with Disabilities, through the Rights of Persons with Disabilities Branch, proposes to coordinate, in collaboration with SAPS, the Department of Justice and Correctional Services, the Department of Social Development, Civil Society Organisations, and persons with disabilities, to roll out a programme to raise awareness on justice and access matters for persons with disabilities.

Internal environment analysis

Through its relocation to new official premises, the Department has reprioritised funds under Office Accommodation for transfer to Compensation of Employees. These savings were approved by National Treasury through an increased allocation in the 2023 MTEF Compensation of Employees baseline allocations with effect from 1 April 2023. The increased allocation will be utilised for the employee cost of living adjustments and to create few additional posts.

Explanation of planned performance over the medium term period:

Research and Knowledge Management

The development of a report on best practices from BRICS countries on poverty reduction programmes will be undertaken through formenting a concept document outlining the objectives, scope and parameters of the research. This concept document will guide the desk top analysis to benchmark these programmes that are being implemented by India, Russia, China and Brazil. However, it is important to also engage with the countries on their experience of implementing these poverty reduction strategies, to learn from their experiences on what works and what doesn't. In this regard, meetings will be held with each of these countries to engage in dialogues on this matter. Once the report has been finalised by collating the desk top study with the findings through the engagements with individual countries; and / or their embassies based in SA, as well as with SA missions based in those countries, it will be shared with key stakeholders in the country so that a concrete action plan can be developed and implemented and a monitoring mechanism outlined.

Explanation of planned performance over the medium term period:

Advocacy and Mainstreaming for the Rights of Youth

The evaluation aims to develop a broad picture of government's youth employment creation programmes across government, their design, effectiveness and efficiency and whether there are any overlaps and gaps. To improve the design, implementation coordination of these programmes. The evaluation will be conducted to assist in improving the performance of existing youth employment programmes and provide evidence that will inform future decision of these programme.

Programme Resource Consideration

Advocacy and Mainstreaming for the Rights of Youth

The Youth employment evaluation programme is being co-funded by the Department of Women, Youth and persons with Disabilities and the Department of Planning, Monitoring and Evaluation. The total budget for the intervention is R1.8 million. The DWYPD will contribute R600 000, whilst DPME contributes R1.2 mil.

The SANDF led National Youth Service (NYS) and the Sector-wide youth employment programme, require funding. Once the Implementation Plans for these programmes are in place, funding will be requested from the National Treasury, government departments, development partners, and the private sector.

This will then be further researched through engagements with each of the four BRICS countries. . The final report will be a collation of both the desk top research and the findings of the engagements with those countries, or their embassies in SA and with the SA missions in those countries, define programmes that SA can implement to advance women, youth and persons with disabilities economically and help take them out of poverty.

Rationale for Erratum and Addendum

This document serves to amend the APP submitted to Parliament in that some indicators that are not within the scope of control of the Department will be removed, others amended to be SMART and the addition of new indicators.

The Department facilitated the establishment of Gender Based Violence Rapid Response Teams (GBVF RRTs) in six provinces, in consultation with COGTA, SALGA and Offices of the Premiers in the six provinces. The provinces where GBVF RRTs were established are Eastern Cape, KwaZulu Natal, Gauteng, Northern Cape, Mpumalanga and Free State Province.

The total number of the GBVF RRTs established is 31 at the District and Local Municipality levels. The role of the department is not only to ensure establishment of these structures but it is also to ensure that they are functional; and are fully capable of executing their main responsibility of coordinating and leading the fight against the scourge of GBVF. It is against this background that the Department will be focussing on building the capacity and mentoring of the members of these GBVF structures.

The training topics to be covered will be based on the findings of the capacity assessment that will be done with the GBVF RRTs. The main objective is to ascertain that GBVF RRTs members understand gender based violence, the role of the various stakeholders who are critical in the fight against GBVF; and are able to respond with agility to GBVF cases in communities.

The training of the GBVF RRTs will be followed by mentorship support where the department will respond to the requests for support made by the various GBVF RRTs. The support will be in the form of linking the RRTs to various post-violence care (PVC) and psychosocial services (PSS) in line with the needs identified by the RRT, providing systems support and organising for in-service training where required.

Reason for removal of the target

Implementation of WECONA Provincial Roll-Out

The DWYP had initially planned to include the target of WECONA Provincial Rollout as part of the strategic focus area of the department to be implemented in the 2023/24 financial year. However, the department had to reconsider the inclusion of WECONA Provincial Rollout as part of the APP for the following reasons: the WECONA structures in the provinces are not yet well established, they are still in the inception phase and are also not yet properly aligned with the WECONA national body, and this is a target that DWYPD is not in full control of in terms of when the roll out will happen. Considering the above reasons, the department will no longer have WECONA Provincial Rollouts in the APP target but will provide support to the national sphere of WECONA.

Implementation of Sanitary Dignity Implementation Framework by provinces

The DWYPD in the financial year 2022/23 conducted an audit on the implementation of the Sanitary Dignity Programme by provinces. Based on the audit, in order to improve the implementation provinces need to put adequate controls as the ones currently in place are not effective. Provincial Sanitary Dignity Committees should be established in order to strengthen the oversight on the implementation of the program. Based on the findings of the audit the DWYPD recommends that the inclusion of the Sanitary Dignity Programme as a target in the APP of the responsible departments. DWYPD will continue with the monitoring of the Provinces on the implementation of the sanitary dignity framework through the Operational Plan.
